Temporary Location

I had indicated in my initial building email that while the architects who are in charge of our building remodel were confident that we could stay in the new building during the duration of construction, that this was subject to change.

After further review by the architects and the City of Golden Valley, as well as the discovery that renovations would become more extensive than originally anticipated, it was determined that keeping our program in the building during the Fall would be untenable. These are all very recent developments and decisions, which is why you are just hearing about it now.

Thankfully, we have found a fantastic space nearby as our temporary home. It is located at 8401 Golden Valley Rd (behind the Holiday Gas Station) and actually provides us with more square footage than we even have now, as well as a very nice kitchen space.

It is the Valley Creek Office Building and is clearly marked from the street. On the first floor is a Health Partners Clinic and we will have the second floor to ourselves. Most importantly, its proximity to our current location will allow for minimal disruptions in transportation and our work/community partnerships.

On Tuesday, October 5th, we will have drop-off at our current location and pickup from the 8401 Golden Valley Rd location. Wednesday, October 6th will be our first full day at the 8401 location. Our plan is to stay at that location until January 15th, when it is expected that the demolition and reconstruction phase will be complete and it will be safe for us to return to 8810.
